## EDITOR'S NOTE

Welcome to the fourth edition of our monthly Insolvency Reports from Insight Data. In this report, we aim to provide you with valuable insights and comprehensive statistics of the current state of the Fenestration industry.

April brought a notable shift in the insolvency landscape across various sectors of the fenestration and construction industry, offering both relief and reflection for all businesses involved. Fortunately, our data reports fewer insolvencies across all sectors – a reassuring indicator following the monthly increases throughout the first quarter of 2024.

And yet, it's important to keep in mind that we shouldn't forget about ongoing challenges. To put things in perspective, in January, 302 succumbed to insolvency pressures. February showed a slight improvement, with 255 insolvencies, but by the end of March, there was a significant increase with 382 cases. While April's numbers are a bit better, with fewer insolvencies compared to the unsettling results of over 900 in the first quarter, it's crucial for stakeholders to work together, manage risks proactively, and plan strategically to keep this positive trend going.

### April 2024 Insolvency Trends:

Our market intelligence reveal a total of 219 companies succumbed to insolvency pressures during this period, with installers and fabricators accounting for 64 cases.

Builders' merchants, main contractors, and small builders were not immune to the prevailing challenges, with 23, 1, and 107 insolvencies recorded respectively.

Architect firms also faced challenges, with 24 recorded insolvencies, raising concerns about the overall health of the construction sector.

At Insight Data, we're committed to empowering our industry with the tools needed to make better business decisions. These monthly statistics stand as a golden opportunity for businesses to leverage our market intelligence and prime themselves against current industry challenges.

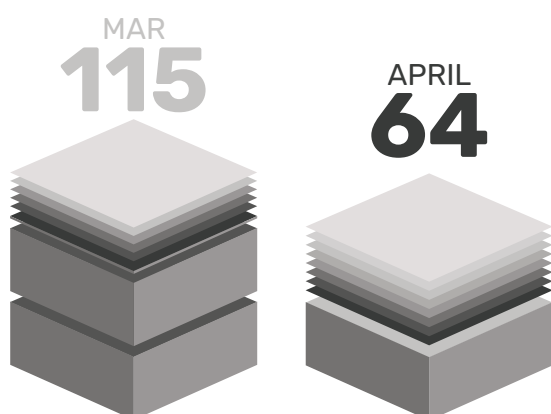

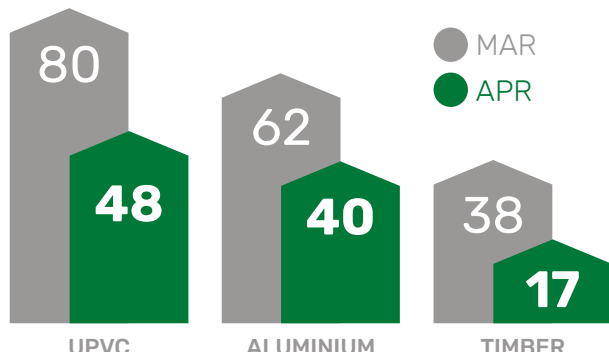

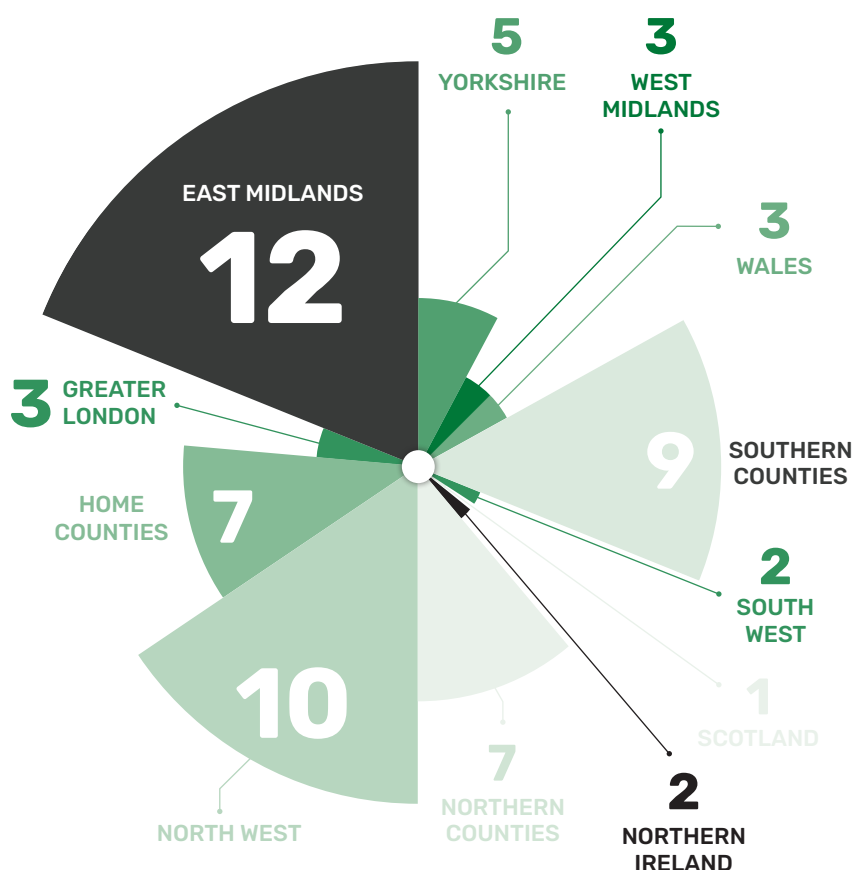
## TOTAL NUMBER OF FABRICATORS & INSTALLERS INSOLVENCIES

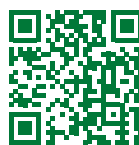
