EDITOR'S NOTE

Welcome to the eighth edition of Insight Data's monthly Insolvency Report, where we continue to provide essential insights and statistics reflecting the ongoing shifts within the glazing and construction industries.

In August, the pressures facing the sector deepened, as indicated by the rise in insolvency numbers. Small builders, in particular, saw a 15.7% increase in insolvencies, growing from 115 in July to 133 in August. Meanwhile, fabricators and installers experienced a 12.1% drop, with insolvencies falling from 99 in July to 87 in August. The most significant rise comes from main contractors and house builders, which surged by 450%, albeit from a low base, increasing from just 2 in July to 11 in August. Architects also, faced more turbulence, with insolvency numbers decreasing by 32.1% from 28 in July to 19 in August.

These statistics offer a snapshot of an unsettled moment for the construction industry, driven by rising interest rates and material costs. The Bank of England's recent rate hikes, designed to combat inflation, are squeezing businesses in the construction supply chain, limiting access to affordable credit and restricting growth. This, combined with high energy costs and a slowdown in new housing projects, creates a challenging economic environment for businesses.

As the government continues its drive to build more homes, these latest figures underline the importance of market agility. For companies operating within these challenging conditions, staying ahead of insolvency trends and understanding where vulnerabilities lie is key.

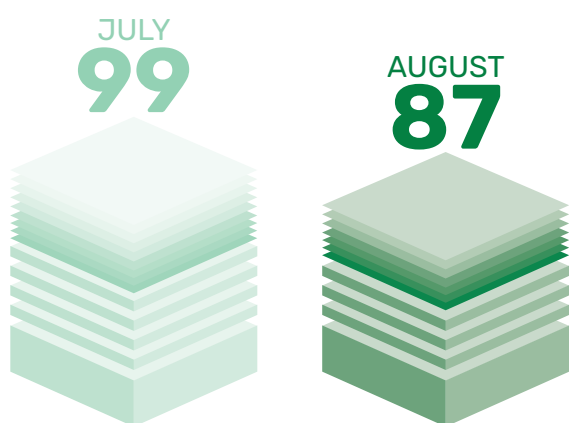

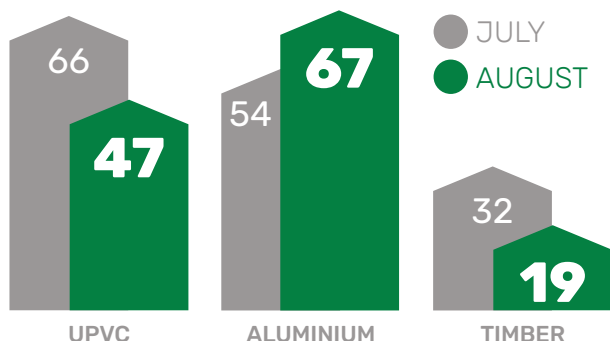

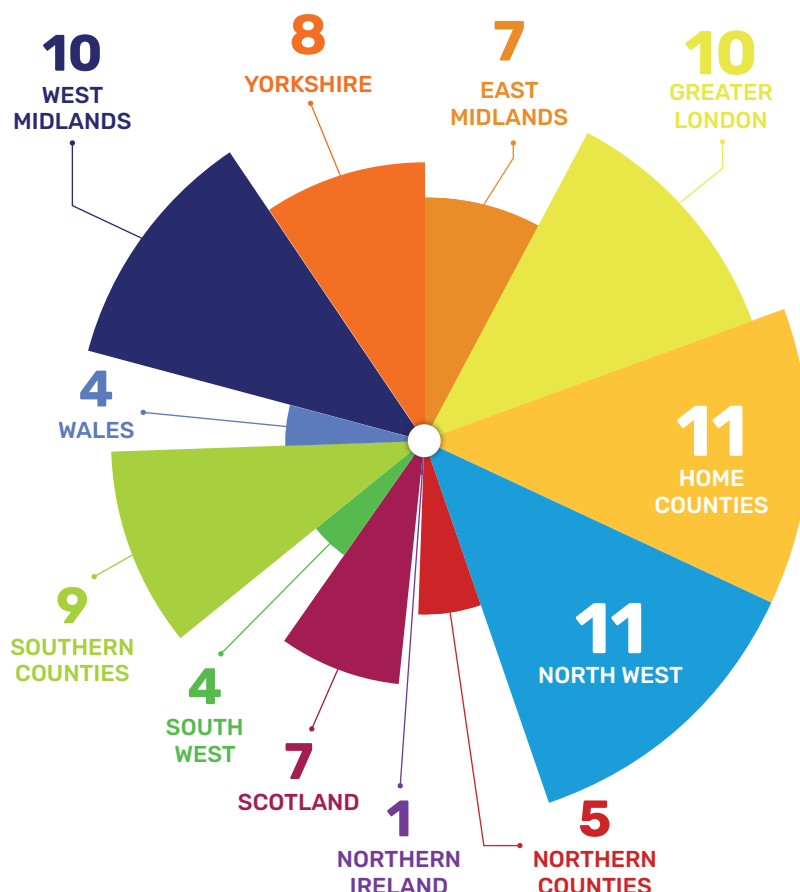
TOTAL NUMBER OF FABRICATORS & INSTALLERS INSOLVENCIES

MAIN CONTRACTORS INSOLVENCIES

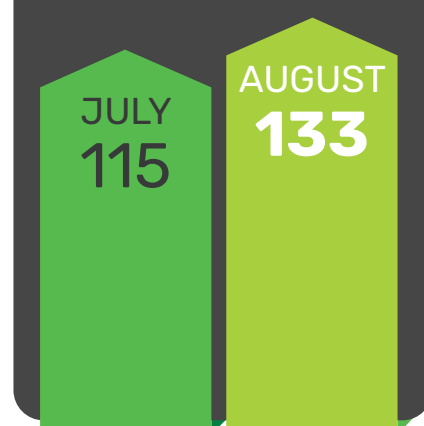
