

# INSOLVENCY REPORT

A closer look at company insolvencies across the glazing & wider construction industry.





## **EDITOR'S NOTE**

Hello.

Welcome to the second edition of our monthly Insolvency Reports from Insight Data. In these reports, we aim to provide you with valuable insights and comprehensive statistics of the current state of the fenestration, construction, and building products industries.

With a meagre 16% decrease in rates of insolvencies since January, the industry continues to contend with alarming levels of businesses who had their company status amended as dissolved, in liquidation, wound up, or no longer trading.

#### February 2024 Insolvency Trends:

Our market intelligence reveals a total of 255 companies succumbed to insolvency pressures during this period, with installers and fabricators accounting for 63 cases.

Builders' merchants, main contractors, and small builders were not immune to the prevailing challenges, with 22, 1, and 137 insolvencies recorded respectively.

Architect firms also faced challenges, with 32 recorded insolvencies, raising concerns about the overall health of the construction sector.

Comparing January and February statistics, it's evident that while there are fluctuations in insolvency numbers across various sectors within the fenestration industry, the overall landscape remains challenging. Economic uncertainties and competitive pressures continue to test the resilience of companies operating within this sector.

However, the data also sheds light on emerging opportunities across the various sectors. With the closure of several competitors, surviving companies have the chance to expand their market share and capitalise on unmet demand. By investing in research and development and appropriately adjusting product offerings and marketing strategies in response, companies can differentiate themselves and carve out a competitive edge in the industry.


