EDITOR'S NOTE

Welcome to the first edition of our monthly Insolvency Reports from Insight Data. In these reports, we aim to provide you with valuable insights and comprehensive statistics of the current state of the Fenestration industry.

It's fair to say the industry has entered the new year on rocky ground. Recent statistics from the Government Insolvency Service reveal that between October and December 2023, construction companies experienced the highest number of insolvencies. The industry, sensitive to shifts in consumer and business behaviour, faced significant challenges in the first month of 2024.

January 2024 Insolvency Trends:

Our market intelligence reveals a total of 302 companies succumbed to insolvency pressures during this period, with installers and fabricators accounting for 66 cases.

Builders' merchants, main contractors, and small builders were not immune to the prevailing challenges, with 33, 4, and 133 insolvencies recorded respectively.

Architect firms also faced challenges, with 46 recorded insolvencies, raising concerns about the overall health of the construction sector.

These statistics highlight the need for businesses in the fenestration sector to reassess their strategies and collaborate with others to ensure their long-term survival. In this challenging time, taking a closer look at these numbers can help businesses make informed decisions and seek new opportunities.

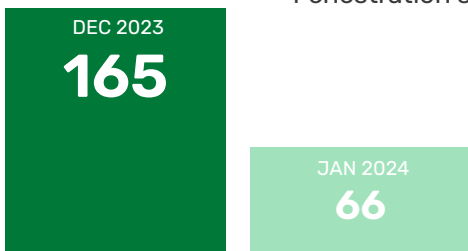
