EDITOR'S NOTE

Welcome to the sixth edition of our monthly Insolvency Reports from Insight Data. In this report, we aim to provide you with valuable insights and comprehensive statistics of the current state of the glazing and construction industries.

June's insolvency statistics come at a critical juncture for our industry. The recent election results have brought the Labour party into power, promising significant changes and new opportunities. With a bold plan to build 1.5 million new homes over the next five years, the demand for an agile and well-equipped response from the glazing and construction sectors is unprecedented.

Despite this ambitious outlook, the industry faced a challenging month with 213 businesses registered as insolvent, closed, or no longer trading recorded. This includes 55 installers and fabricators, 16 builders' merchants, 3 main contractors, 23 architectural practices, and 116 local builders. These figures conclude the end of the second financial quarter, and while there's been a 21% decrease in insolvencies compared to the first quarter, the need for strategic adaptation and resilience throughout the industry clearly remains.

The proposed housing boom presents both a challenge and an opportunity. While the increase in demand for new-builds can spur growth and recovery, it also necessitates that companies are prepared to meet these demands efficiently. The current insolvency trends underscore the importance of staying informed and adapting to the evolving economic landscape.

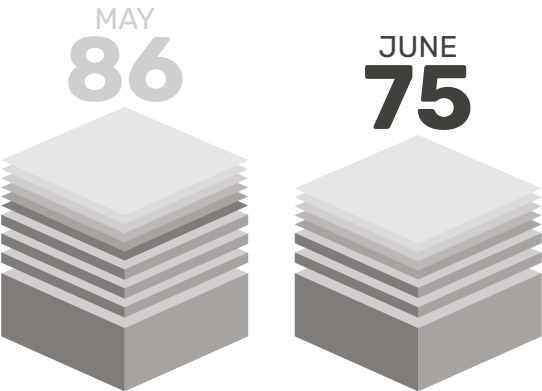

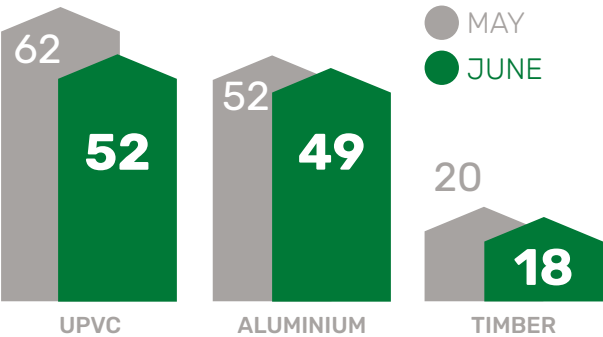

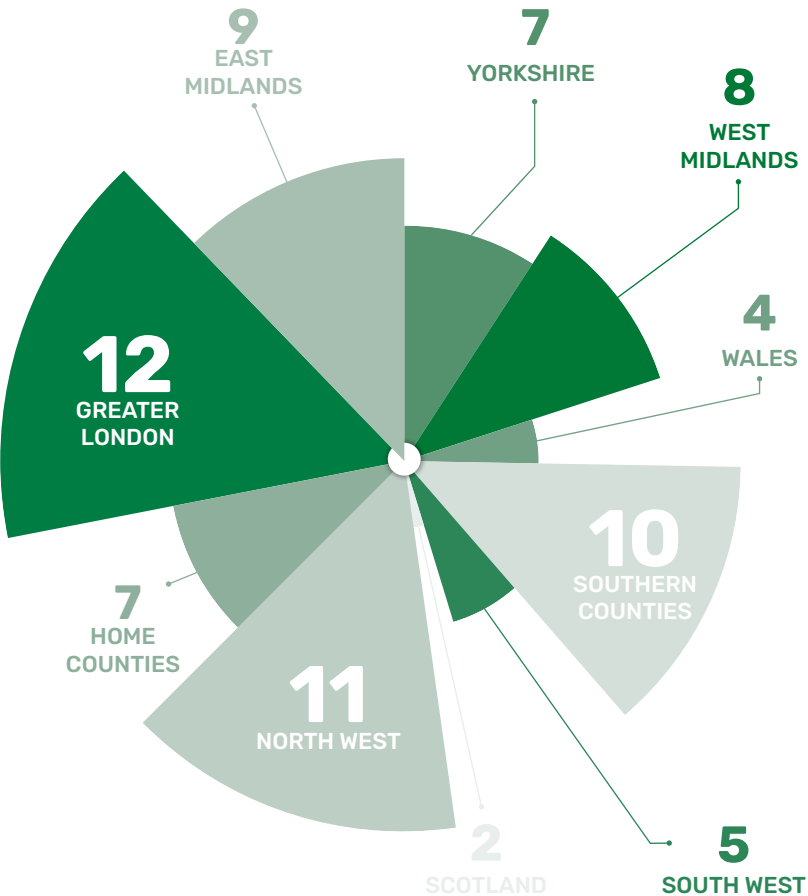
TOTAL NUMBER OF FABRICATORS & INSTALLERS INSOLVENCIES
