## EDITOR'S NOTE

Hello,

Welcome to the third edition of our monthly Insolvency Reports from Insight Data. In these reports, we aim to provide you with valuable insights and comprehensive statistics of the current state of the Fenestration industry.

With a staggering 50% increase in rates of insolvencies since February, the industry continues to contend with alarming levels of businesses who had their company status amended as dissolved, in liquidation, wound up, or no longer trading.

### March 2024 Insolvency Trends:

Our market intelligence reveals a total of 382 companies succumbed to insolvency pressures during this period, with installers and fabricators accounting for 115 cases.

Builders' merchants, main contractors, and small builders were not immune to the prevailing challenges, with 26, 6, and 190 insolvencies recorded respectively.

Architect firms also faced challenges, with 45 recorded insolvencies, raising concerns about the overall health of the construction sector.

This month's report concludes the statistics of insolvency up-to the first two weeks of March. The fluctuating trends in insolvencies underscore the volatility and challenges prevalent in the industry. Factors such as economic uncertainties, supply chain disruptions, and regulatory changes likely contribute to the observed patterns, and all beg the question: how can businesses in the fenestration industry avoid participating in such a growing trend?

With the closure of several competitors, surviving companies have the chance to expand their market share and capitalise on unmet demand. By investing in research and development and appropriately adjusting product offerings and marketing strategies in response, companies can differentiate themselves and carve out a competitive edge in the industry.





## TOTAL NUMBER OF FABRICATORS & INSTALLERS INSOLVENCIES


