EDITOR'S NOTE

Welcome to the fifth edition of our monthly Insolvency Reports from Insight Data. In this report, we aim to provide you with valuable insights and comprehensive statistics of the current state of the Fenestration industry.

May's insolvency statistics reveal slight increases in some areas compared to April, but these increases are far less severe than those seen at the beginning of the year - providing a cautiously optimistic outlook as the UK economy starts to show signs of recovery.

While any rise in insolvencies is unwelcome, the slower rate of increase in May is significantly less dramatic than those recorded in the first quarter. This trend is encouraging as it indicates that businesses are adapting to the current economic environment and finding ways to navigate through these turbulent times.

May 2024 Insolvency Trends:

Our market intelligence reveals a total of 243 companies succumbed to insolvency pressures during this period, with installers and fabricators accounting for 86 cases.

Main contractors, and small builders were not immune to the prevailing challenges, with 3, and 122 insolvencies recorded respectively.

Architect firms also faced challenges, with 29 recorded insolvencies, raising concerns about the overall health of the construction sector.


