A closer look at company insolvencies across the glazing & wider construction industry.

EDITOR'S NOTE

Welcome to the tenth edition of Insight Data's monthly Insolvency Report which, as always, includes key insights and statistics reflecting the changes within the glazing and wider construction industries.

In October, the first Labour government financial statement in 14 years was delivered and included adjustments to employer National Insurance contributions which means businesses of all sizes will be paying higher rates per employee. While this blow will undoubtedly have a negative knock-on effect when it's implemented next year, let's first take a look at the current figures to understand the here and now.

The overall picture to the end of October seems to be one of continuing stagnation and uncertainty. Builders' merchants suffered the worst, with 21 insolvencies in October, an increase of 50% from September. Architects have experienced similar difficulties with 27 firms going bust last month, up from 25 in September and a percentage change of 8.

When exploring the number of insolvencies among fabricators and installers in the glazing industry, there was a slight drop from 90 in September to 68 in October. Local Builder insolvencies also decreased from 106 in September to 85 in October. The figure for main contractors with a turnover of more than £5million, however, remained the same for October with just three firms going under in both months.

Although it's positive to see insolvency rates have slowed in comparison to earlier in the year, the Labour Budget and result of the recent US election will unfortunately lead to a new wave of challenges for companies to mitigate. At the time of writing, we're in a period of calm before the storm. It's more important than ever for companies to invest now in the solutions that will help them to navigate these upcoming difficulties. 
